## BUSINESS LICENCE BYLAW

## VILLAGE OF LOON LAKE BYLAW NO. 03-2022

A BYLAW TO CLASSIFY, REGULATE AND LICENCE ANY BUSINESS, TRADE OR CALLING NOT ASSESSABLE FOR THE PURPOSE OF BUSINESS TAXATION IN RESPECT TO THEIR BUSINESS, TRADE OR CALLING.

The council of the Village of Loon Lake in the Province of Saskatchewan enacts as follows:

## **Short Title**

1. This Bylaw may be cited as the "Business Licence".

## PART I PURPOSE AND DEFINITIONS

- 1. In this bylaw the expression "transient trader" shall have the meaning ascribed to it by the Urban Municipality Act.
- 2. No person shall carry on any business, trade or calling set out in Section 8 of this bylaw within the municipality unless he has in his possession a valid and subsisting licence for the purpose issued in accordance with the provisions of this bylaw.
- 3. The Administrator of the municipality is hereby authorized to issue a licence to any person carrying on business, trade or calling in the municipality:

a. Who is not assessable by the municipality for the purpose of business taxation in respect to that business, trade or calling; and

- b. Who makes application for such licence stating specifically the nature of his business in the municipality; and
- c. Who tenders with his application the proper licence fee as provided for in Section 8.
- 4. Every licence issued under the authority of this bylaw unless suspended or evoked shall expire on the thirty-first day of December of the year of issue.
- 5. Every licence issued shall specifically state the kinds of services, goods or merchandise which the licence is authorized to offer for sale or take orders for as the case may be and whether in the case of goods and merchandise, he may offer the same for sale by retail or by public auction or both. Such licence shall also state the restriction as set forth in section 6 hereof.
- 6. No person to whom a licence has been granted under this bylaw shall offer to sale services, goods or merchandise or solicit orders for future delivery of goods or merchandise within the village:
  - a. Other than a kind of kinds described in the licence; or

b. By any method except as stated in the licence; or

- c. At any time or during any period when shops within the village offering for sale or taking orders for similar services, goods or merchandise are required by village bylaw to be and remain closed.
- 7. Every person licenced under this bylaw shall, at all reasonable times, upon request of the Administrator, the bylaw enforcement officer or licence inspector, or any peace officer, produce such licence for inspection purposes.
- 8. The fee payable for a licence under this bylaw shall be as follows:

a. For a transient trader

\$100.00

- b. For a contractor who enters into contracts for the construction, alternation, repair, or removal of buildings or structures, the installation of heating units, plumbing or other fixtures, electric wiring, or performance of other similar work in the municipality

  No charge
- 9. Any person who contravenes the provisions of this bylaw is guilt of an offence and upon conviction, shall be liable to (the Penalty provided for by the General Penalty Bylaw of the Municipality or other specified penalty).
- 10. This bylaw shall repeal bylaw No. 9/86 and will come into force upon third reading and adoption.
